PC agree with the suggestion that the Green Light Trust building and adjacent car parking area be removed from the LGS designation, i.e., be separated out on the relevant maps.
2	Babergh District Council LGS 4: Hall Mead Open Space	The map with the whole of the green showing on either side of the road should be included.
2	Babergh District Council LGS 8: Hanningfield Green	PC agree the error noticed. It should read LWL 10-8.

As he will know, the view that has been added is the one he requested of Frithy Wood. The errors and discrepancies in the review are covered by Babergh District Council and have been responded to by Lawshall Parish Council.
11	Resident - Squirrell	Harts Green is correctly identified as a hamlet as part of the general character of Lawshall. It is shown on the Policies Map and in the Character Assessment where it is mentioned by name. It is described more fully on page 14 of the Character Assessment.
		Hamlet is only used as a descriptive name not as a formal designation.In the 2017 NHP it was not classified as a cluster because it did not have eight or more dwellings like Melon Green. Neither Harts Green nor Melon Green have a Settlement Boundary for the same reason.
